

Discussion on who can live at the property. Conclusion, It is A.Margies home but it is also our home, it comes with maintaining the home for wider whanau to be able to stay there. It will be overseen by the trustee's to ensure that everyone is made to feel welcome and comfortable at the house if they were to stay there. If anyone living in the house makes that impossible, then action will be taken to correct it.

Bottom line, other whanau may stay in the house with A.Margie as long as they adhere to the rulings of the trustees. This will include rent, board and upkeep of the property.

#### Whareama

During the year Marija and other land owners spoke with Judge Harvey and the land solicitor given to to represent us, via tele-conference to try and sort out what had happened to this land and how we can go forward.

Long story short. We will have to pay legal costs in order to have this matter settled in the high court of NZ. We are awaiting the valuation of the property, which has been ordered by the Judge. Once we have the worth of the land it will then be up to ourselves (the owners) to discuss whether or not it is worth the legal costs. Ourselves and 1 other owner have the majority shares in the land so it will probably be us that pays the most.

Everyone in the meeting was happy for the trustees to make those decisions once the time comes and it is needed.

### Waikekeno

Contacted Haami Te Whaiti to gain paperwork and information about the land and its rentals. Yes there is supposedly rent being paid for this land, an account where the land money goes into and is to pay for a fence to put up around the land. Marija asked for that account and its statements as well as the minutes that passed this action.

He has never emailed back and Marija is now lodging an application of complaint towards the trustees of this land with the Maori Land Courts. Marija feels like there is something dodgy going on here as her last contact with Uncle Boy (a then trustee, he has now passed) was that the money had gone and there was no fence.

She will keep on pushing on.
